### 1. **Apologies for absence:** To receive apologies for absence.

2. **Declarations of Interest**: Following adoption by the Council on 11 July 2012, of the Northway Parish Council Code of Conduct, Members are invited to declare any interest they may have in the business set on the Agenda to which the approved Code of Practice applies. #### 3. Garden Town:-

### a) Ashchurch/Northway Bridge

- At the request of Tewkesbury Borough Council, Gloucestershire County Council have agreed to design the road layout from the bridge to Northway from the proposed new bridge. To consider any comments or input the Parish Council may like to submit to Gloucestershire County Council at this early stage in the road planning. This could include the larger areas of in and around Northway as well as the specific roads leading off the bridge into Northway. To determine.
- On the information provided to date by Tewkesbury Borough Council and, prior to receipt of a planning application for the bridge being submitted, to consider whether the Council should begin to formulate a draft of its views, which may later be used in any response to the application when received. To determine.
- Following receipt of the letter forwarded to residents in Northway and Ashchurch by Tewkesbury Borough Council in relation to the bridge, to consider whether there is anything the Council could do to ease the confusion that appears to have arisen. i.e. suggest a 'zoom' or other style platform question and answer meeting for residents with the Garden Town Project Officers to allow them to ask questions directly, as they would have been able to at the Share event. To determine.
- b) **Garden Town** The Chairman has received a request to be part of a regular joint meeting with Tewkesbury Garden Town Project officers and Ashchurch Rural Parish Council. The Chairman has already agreed he would be happy to do this. To consider and approve.
- c) To consider any other matters relating to the Bridge and the Garden Town. To determine any necessary action.
- 4. Covid-19 Emergency Community Grant Following Cllr MacTiernan's application to this fund it has now been approved by Tewkesbury Borough Council and, as agreed, part of the £1,000 can be used to reimburse the Council for the Covid-19 flyer sent out. To consider how to utilise the remaining funds for the benefit of Northway. To determine.
