## P/52/19 Neighbourhood Planning

Members considered GRCC's Presentation about Neighbourhood Planning and considered whether to recommend this to Full Council. The Clerk reminded Members that they could, if they wished, just do a one policy NDP which would speed up the process. The Council could potentially contract someone to undertake the technical work and, if passed, this would mean the Parish Council would have 25% uncapped of any CIL monies. Without a NDP the Council would be eligible for 15% capped (maximum of £100 per property). The Plan could still be added to at a later date, but the whole process would have to be followed. Councillors/Volunteers would still have to undertake a lot of 'leg work' even if a technician was contracted to undertake the reports. The Project would have to be Community Led although the Parish Council would own the Plan.

If Members wished to progress this the next step would be to recommend it to Council and arrange a public meeting to gauge interest. Different options for making residents aware of the meeting were considered i.e. web page, facebook - including online survey, posters, contacting schools.

Members considered what their one policy would be if the Plan was progressed on that basis and identified Loss of Identity, Roads/Traffic and Pollution. A Plan would naturally increase Northway's identity and as the traffic/pollution was the greatest concern Members AGREED this was the best policy to progress.

It was noted that a lot of the older generation were not computer savvy and there was a lot of apathy in Northway i.e. lack of attendance at the Veteran's coffee morning. It was noted that the Newsletter was another method that could be used.

Cllr Ward PROPOSED that the Planning Committee make a recommendation to Full Council that they consider approval of progressing a one policy Neighbourhood Plan. Cllr Phennah SECONDED.

## P/53/19 Correspondence received after 11<sup>th</sup> July 2019

The Clerk reminded Members that she had sent an email regarding the possibility of a couple of Councillors having a regular 'catch up' with Annette Roberts regarding the Ashchurch Masterplan. She had meetings with Ashchurch Parish Council and has offered the same opportunity to Northway if they would like this. The Council would need to flag up any queries to present to Annette. It was noted that Tewkesbury Borough Council had not been very responsive to previous correspondence that Northway had sent them and this might be a way to raise Northway's identity. Members felt this would be beneficial and a few said they had replied to the Clerk but for some reason these had not been received. Cllrs Terry, Ward, Roberts, Shelton and Phennah expressed as interest in meeting with Annette. It was also suggested that a 'wider' meeting might be more suitable as there were a number who were interested.
