Tewkesbury Borough Council: Tewkesbury Garden Town - An invitation had been received for one person to be nominated to sit on the Programme Oversight Board (both Northway and Ashchurch were being offered a position). This was a separate role from the Parish Liaison Group which was made up of councillors from any parishes within the Borough (Cllr Barnes for Northway). The Parish Liaison Group would also be nominating one representative from their group to sit on the Programme Oversight Board. It was noted that this would involve a face to face meeting every 2-3 months with the first one being held on 20th December between 2.00pm and 4.00pm at Tewkesbury Park.
