21/00451/OUT - Land to the North West of Fiddington

Outline application for residential development (up to 460 dwellings), a primary school, associated works, ancillary facilities and infrastructure, open space, recreation facilities and landscaping. Vehicular access from the A46 (T) and Fiddington

Although outside of Northway parish, this application related to an adjacent parish and would impact on Northway. Members had reviewed the details prior to the meeting.

Cllr Ward PROPOSED an objection to this application on the grounds that work had not progressed to improve congestion on the A46, which was already at capacity. This site, along with the 850 new homes already approved, would gridlock the local road network. Furthermore, the site was situated close to the Tirlebrook which regularly flooded during times of substantial rainfall and, even if it did not cause flooding issues on this site, it would raise water levels in Tewkesbury and Northway. Cllr Terry SECONDED.
