5. **Matters Arising from the Previous Meeting:**

RS/06/22 Community Speed Watch Fund – The Council bid for a Mobile VAS and Community Speedwatch camera from the PCC Fund was successful in both applications.

6. **Vehicle Activation Sign (VAS):** To consider the best way to manage the Vehicle Activation Sign (VAS).
 - Plan for rotation of locations including length of time the VAS will remain in one location.
 - Plan for how the VAS will be erected and moved around (and by whom) to include consideration of change of batteries.

7. **Auto Speedwatch Camera:** To consider management of Camera
