### S/38/19 <u>Training</u>

The Clerk updated Members regarding the 'Being a Better Councillor' course hosted by the Parish Council on 21<sup>st</sup> November 2019. The Clerk informed Members that ClIrs Phennah, Porter and Barnes had put themselves on the list. ClIr Mackenzie may have work commitments on that day and ClIr Sollis had not confirmed either way.
