## S/09/23 **Code of Conduct 2021**

The new Code of Conduct had been issued in 2021 but Northway Parish Council had not yet adopted it. The Clerk contacted the Borough Solicitor when it had been first received but had been advised to hold back adopting it until the Borough Council had reviewed it to include training. As the Borough Council have to deal with Code of Conduct issues was better that all parishes in the district adhere to the same code. The Borough Council had just adopted the Code and now wanted parishes in the district to adopt it before the May 2023 Elections if possible.

Members went through the Code page by page, and the Clerk highlighted the differences between the new one and the existing, although they were few. Members had no objection to any of the changes and Cllr Roberts PROPOSED that this was recommended to Full Council for adoption.
