It was noted that houses were necessary, but concerns were expressed relating to the location, being directly opposite a school, where parking and speeding issues were already a problem. Cllr Roberts PROPOSED that an objection was made due to additional traffic at this location which was in a sensitive area, with a school directly opposite and loss of privacy to neighbours. Cllr Barnes SECONDED.

It was noted that complaints regarding this application had been seen on social media. One objection from a resident had also been received. This related to the impact it would have on their property, being overshadowed.
